HOLD HARMLESS WAIVER

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

The Pied Piper Swim School, Inc. which operates as a swim school and also trades as Creative Connections Art Studio, hereinafter collectively referred to as "Pied Piper", has put in place preventative measures to reduce the spread of COVID-19; however, cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending the activities of Pied Piper could increase your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending Pied Piper activities and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at Pied Piper activities may result from the actions, omissions, or negligence of myself and others, including but not limited to, Pied Piper employees, agents, representative, trustees, volunteers, and program participants and their families.

It is my intent that my child(ren), as a participant of Pied Piper swim school classes and activities and/or Creative Connections Art Studio classes and activities, that I am agreeable to the following: I acknowledge that I am aware that there are risks to my children and myself of exposure to directly or indirectly arising out of, contributed to, by, or resulting from an outbreak of any and all communicable disease, including but not limited to, the virus "severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2)" which is responsible for Coronavirus

Disease (COVID-19) and/or any mutation or variation thereof; In consideration of having the opportunity to participate in swim school classes and activities and/or art school classes and activities and in acknowledging that I am aware of and willing to assume the risks associated with this activity, I, on behalf of my child(ren), voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at any Pied Piper activities ("Claims"). On my behalf, and on behalf of my child(ren), our heirs, assigns and/or successors, we hereby release, covenant not to sue, discharge, or hold harmless Pied Piper and all of the aforesaid entities' trustees, agents, volunteers, employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any and all of the aforesaid entities' trustees, agents, volunteers, employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Pied Piper activities.
